### **PRIVACY POLICY**

This Privacy Policy describes how EMP Capital Group and its affiliates, subsidiaries, and related entities (collectively, "EMP," "we," "our" or "us"), processes Personal Information through our website at **ProsperBrooklyn.com** (the "Site"). Unless specifically stated otherwise, this Privacy Policy applies to Personal Information that we gather or collect via the Site and any other EMP website or online service that posts a link to this Privacy Policy.

For purposes of this Privacy Policy, "Personal Information" means information that identifies, relates to, or could reasonably be linked with an individual. Personal Information does not include publicly available, deidentified, or aggregated information.

These technology companies and advertisers may use, store, or access cookies and other tracking technologies to collect or receive information from across the internet.

### Use of Personal Information

We retain and use Personal Information in connection with the operation of our business, including to:

- Provide Services or Process Transactions, including by maintaining or servicing your account; operating and maintaining our Site; providing information about our Site and services; processing your payments and other transactions; communicating with you about our Site and services; and responding to your requests and questions.
- Communicate with You, including providing account notifications or service
  order updates; responding to your questions or feedback; confirming your
  preferences; providing you information about our Site and services; and
  contacting you regarding services, billing, and transactions; updating you
  about features and offers that we believe will be of interest to you; informing
  you about sweepstakes, contests, or promotions in which you have
  participated; and responding to your questions or other requests; and
  conducting user surveys.
- Operate Our Business, including performing system administration and technology management; carrying out internal administration, such as recordkeeping and auditing; identifying prospective tenants, partners, service providers, and vendors; managing our relationships with our tenants, partners, service providers, and vendors; and fulfilling other purposes disclosed at the time you provide your Personal Information.
- Conduct Business Analytics, including evaluating how our Site performs; tracking and responding to quality and security issues; forecasting and planning; developing statistics on engagement with our Site; and measuring how well marketing and promotional activities perform.
- Maintain Security and Integrity, including protecting our Site from cyber
  risks; authenticating users; preventing, identifying, investigating, and
  responding to fraud, illegal or malicious activities, and other liabilities;
  enforcing our policies and terms; protecting our rights; fulfilling our legal
  obligations; and generally providing you with a secure experience when using
  our Site.
- Perform Quality, Safety, and Internal Research, including evaluating how our Site performs; repairing or improving the quality of our Site; tracking and responding to quality and security issues; and developing new or enhanced products and service offerings.

- For Advertising and Marketing, including measuring the use of our Site and
  effectiveness of our advertising and marketing; and uncovering insights to

  functionalities, such as personalized experiences.
- For Legal and Compliance Purposes, including complying with applicable law, court order, governmental regulations, or other legal obligations; assisting in an investigation, regulatory requests, litigation, or arbitration; protecting and defending our rights and property, or the rights or safety of third parties; enforcing our terms, policies, or any agreements with third parties; comply with health and safety obligations; and prevent crime.

#### Disclosure of Personal Information

We may disclose your Personal Information for the purposes described above to the following parties:

- Our group of companies, including with our affiliates, subsidiaries, locations, and brands.
- Agents, vendors, consultants, and other service providers so that they may
  provide their services to us, including customer service, Site operation and
  maintenance, product and customer service improvement, promotional
  support, payment processing, auditing and quality control, communication,
  and other business operations.
- Other parties at your direction or through your action.
- Vendors and other parties for marketing purposes, to improve our products and Site, or to provide you with products and services that may interest you.
- Advertising partners for the purposes of ad targeting, remarketing, and customized advertising content.
- Government or private parties to comply with law or legal process, respond
  to requests from public and government authorities, enforce our terms and
  conditions, protect our operations and our rights, privacy, safety or property
  of you or others, and allow us to pursue available remedies or limit the
  damages that we may sustain.
- Our insurers and professional advisors, to manage risk, exercise or defend against legal claims, and otherwise obtain professional advice.
- Third parties as part of or during negotiations of any reorganization, acquisition, merger, sale, joint venture, assignment, transfer, or other transaction where another party assumes control over all or part of our business, assets, or stock (including in connection with any bankruptcy or similar proceeding).

# **Data Security**

We take reasonable steps to secure your Personal Information. However, no data storage or transmission can be guaranteed to be completely secure and without risk. Thus, no storage or processing of your Personal Information or other information on the Site, or on other servers or databases to which the information may be transferred, can be guaranteed to be completely secure.

# Sweepstakes, Contests, and Promotions

We may use your Personal Information to send you marketing materials; conduct surveys, contests, and sweepstakes; and to award prizes. We may request additional information to participate in contests and surveys (such as your contact information, personal opinions, preferences, and interests).
